

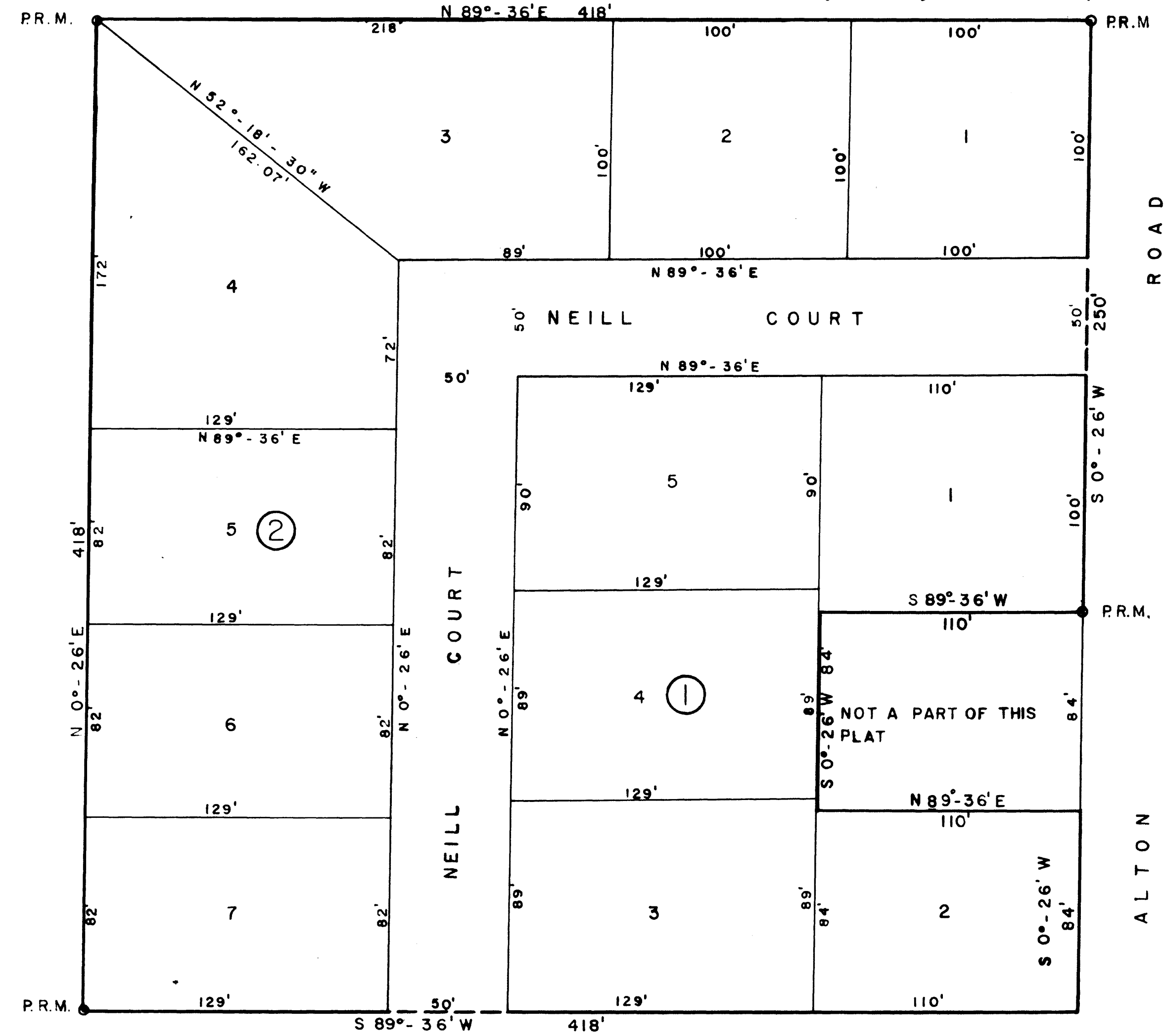
BUTLER COURT

STARKE, BRADFORD COUNTY, FLORIDA

A REPLAT OF A PORTION OF BLOCK 6 OF GASKINS ADDITION TO STARKE AS PER PLAT THEREOF
RECORDED IN DEED BOOK J, PAGE 147 OF THE PUBLIC RECORDS OF SAID COUNTY AND BEING
MORE PARTICULARLY DESCRIBED IN THE CAPTION.

CAPTION:

Commence at a Permanent Reference Monument at the Northeastly corner of said Block 6 for point of beginning and run thence S 0°-26'W, along the Easterly Boundary thereof, 250 feet to a Permanent Reference Monument; run thence S 89°-36'W and parallel to the Southerly Boundary of said Block 6, 110' to an iron stake; run thence S 0°-26'W and parallel to said Easterly Boundary 84 feet to an iron stake; run thence N 89°-36'E and parallel to said Southerly Boundary, 110 feet to said Easterly Boundary; run thence S 0°-26'W along said Easterly Boundary, 84 feet to the Southeastly corner of said Block 6; run thence S 89°-36'W, along said Southerly Boundary, 418 feet to the Southwestly corner of said Block 6; run thence N 0°-26'E along the Westerly Boundary thereof 418 feet to the Northwestly corner of said Block 6; run thence N 89°-36'E along the Northerly Boundary thereof 418' to point of beginning.
