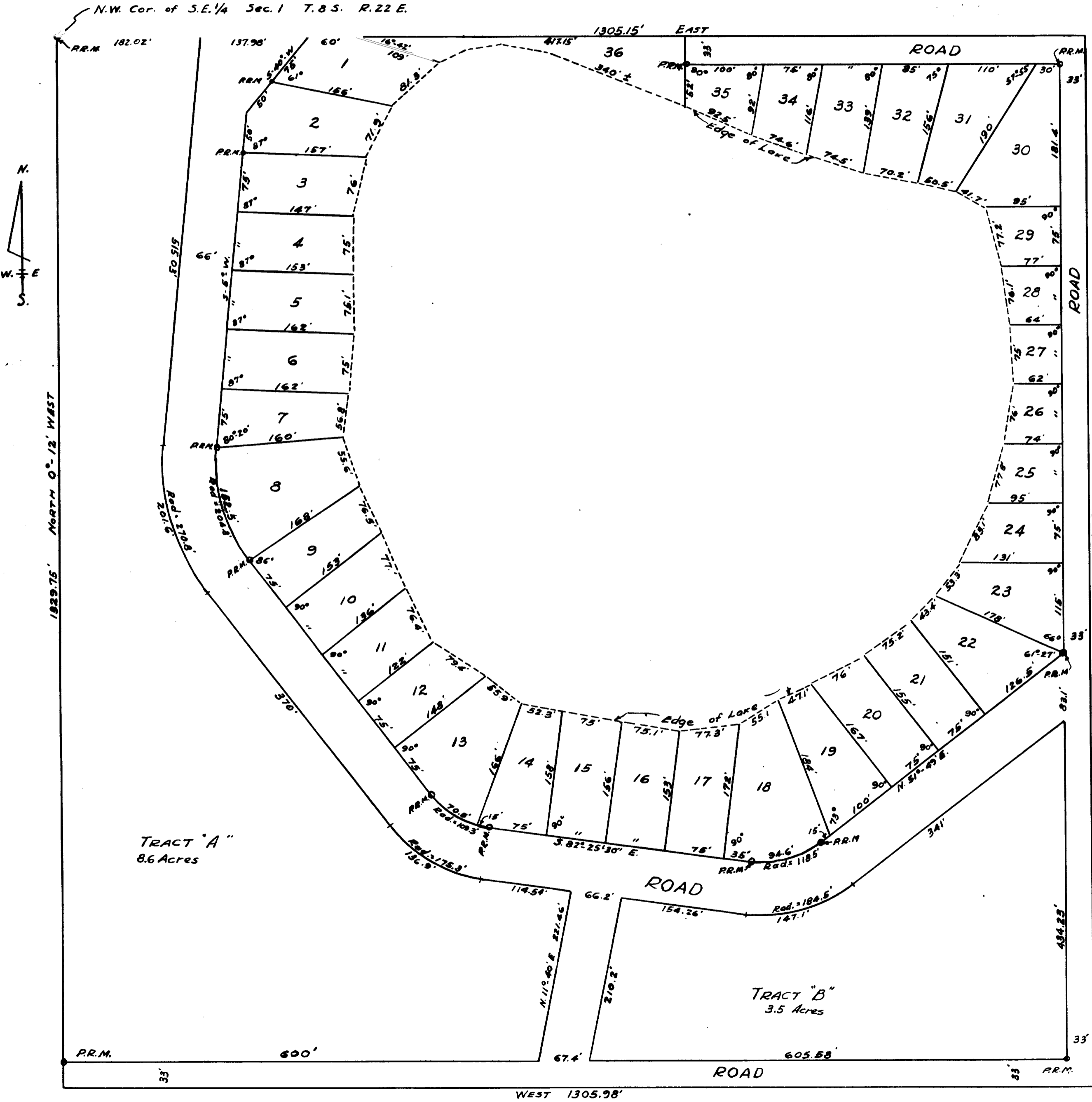
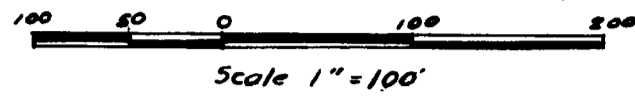


EMERALD LAKE.
