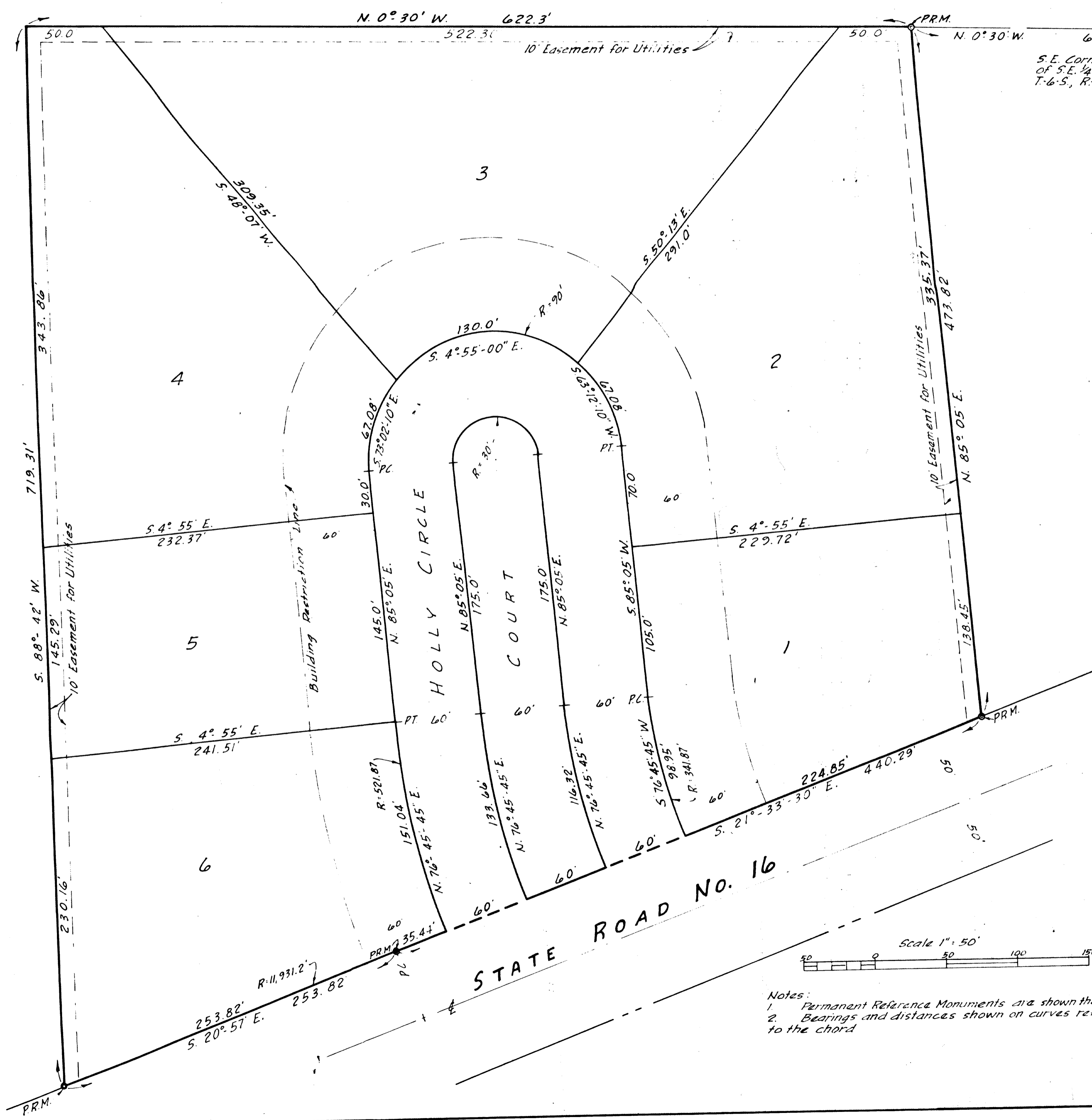


HOLLY CIRCLE BRADFORD COUNTY, FLORIDA

A SUBDIVISION OF PART OF THE S.W. 1/4 OF THE S.E. 1/4 OF SECTION 17,
TOWNSHIP 6 SOUTH, RANGE 22 EAST. THE LAND HEREBY SUBDIVIDED
BEING MORE PARTICULARLY DESCRIBED IN THE CAPTION



CAPTION:
Commence at the Southeast corner of the Southwest quarter (S.W. 1/4) of the Southeast quarter (S.E. 1/4) of Section 17, Township 6 South, Range 22 East, and run thence N. 0° 30' W., along the Easterly boundary thereof, a distance of 691.1 feet to a Permanent Reference Monument (hereinafter referred to as P.R.M.), for the point of beginning.
From the point of beginning thus described, continue N. 0° 30' W., a distance of 622.3 feet, to an iron stake; run thence S. 88° 42' W., a distance of 719.31 feet, to a P.R.M. on the Easterly boundary of the right-of-way of State Road 16; run thence in a Southeasterly direction, along last aforesaid Easterly boundary and along the arc of a curve concave to the East and having a radius of 11,931.2 feet, a chord distance of 253.82 feet to a P.R.M. at the end of said curve, said chord having a bearing of S. 20° 57' E.; run thence S. 21° 33' 30" E. along last aforesaid Easterly boundary, a distance of 440.29 feet to a P.R.M.; run thence N. 85° 05' E., a distance of 473.82 feet to point of beginning.

ADOPTION AND DEDICATION
