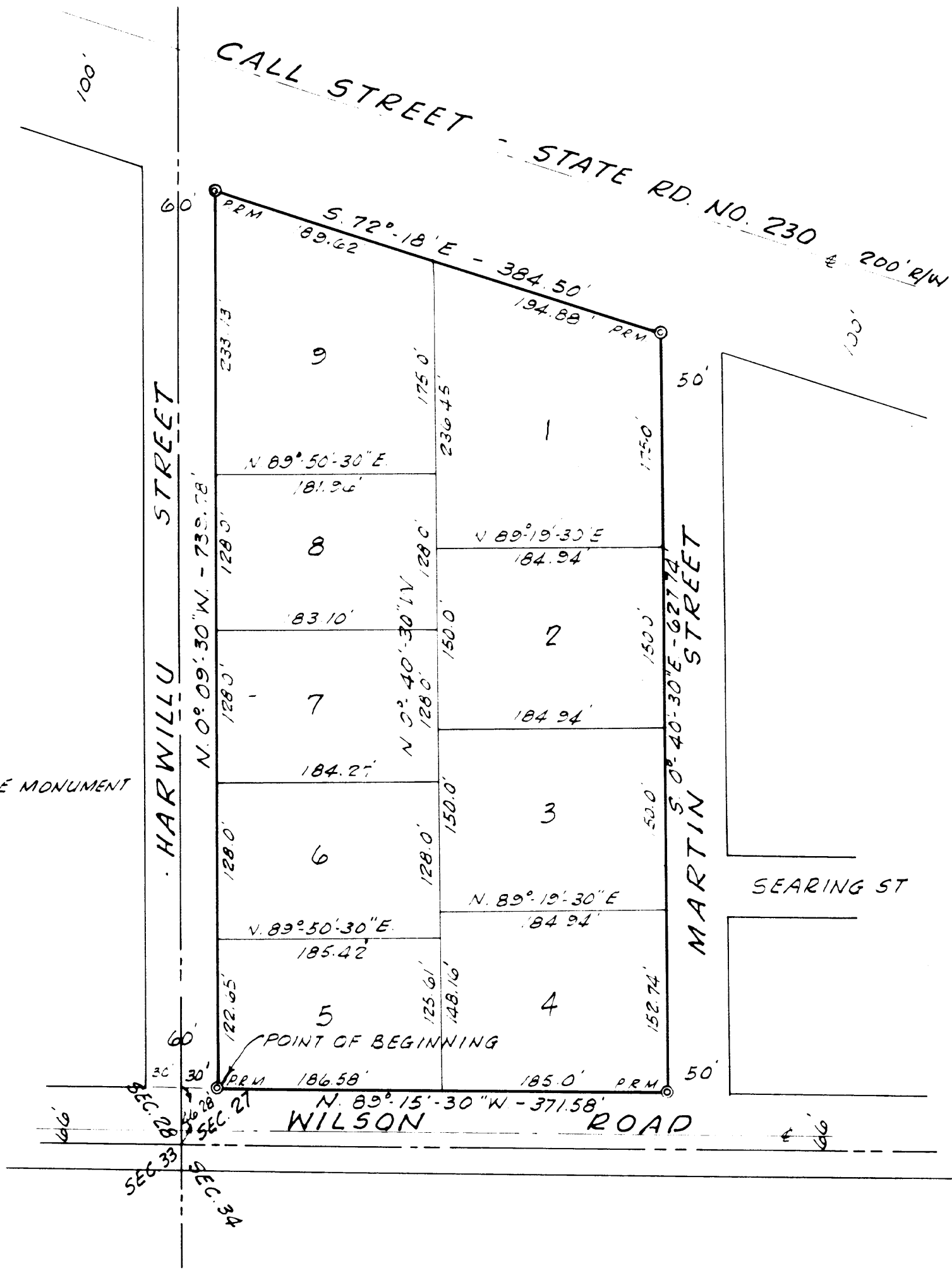
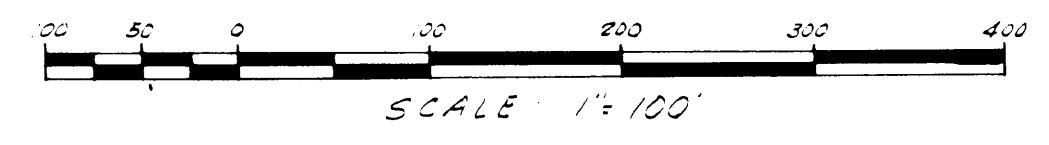


LA FLORESTA

CAPTION
 COMMENCE AT THE SOUTHWEST CORNER OF AFORESAID SECTION 27 AND RUN THENCE N. 0° 09' 30" W. ALONG THE WESTERLY BOUNDARY THERE OF A DISTANCE OF 46.28 FEET TO THE NORTHERLY BOUNDARY OF THE RIGHT-OF-WAY OF WILSON ROAD; RUN THENCE S. 89° 15' 30" E. ALONG SAID NORTHERLY BOUNDARY A DISTANCE OF 30 FEET TO A PERMANENT REFERENCE MONUMENT FOR POINT OF BEGINNING.
 FROM POINT OF BEGINNING THUS DESCRIBED, RUN N. 0° 09' 30" W. AND PARALLEL TO AFORESAID WESTERLY BOUNDARY, A DISTANCE OF 739.78 FEET TO A PERMANENT REFERENCE MONUMENT ON THE SOUTHERLY BOUNDARY OF THE RIGHT-OF-WAY OF STATE ROAD NO. 230, RUN THENCE S. 72° 18' E. ALONG SAID SOUTHERLY BOUNDARY, A DISTANCE OF 384.50 FEET TO A PERMANENT REFERENCE MONUMENT AT THE INTERSECTION OF SAID SOUTHERLY BOUNDARY AND THE WESTERLY BOUNDARY OF THE RIGHT-OF-WAY OF MARTIN STREET, RUN THENCE S. 0° 40' 30" E. ALONG LAST AFORESAID WESTERLY BOUNDARY, A DISTANCE OF 627.74 FEET TO A PERMANENT REFERENCE MONUMENT AT THE INTERSECTION OF LAST AFORESAID WESTERLY BOUNDARY AND AFORESAID NORTHERLY BOUNDARY OF THE RIGHT-OF-WAY OF WILSON ROAD; RUN THENCE N. 89° 15' 30" W., ALONG SAID NORTHERLY BOUNDARY A DISTANCE OF 371.58 FEET TO THE POINT OF BEGINNING.
