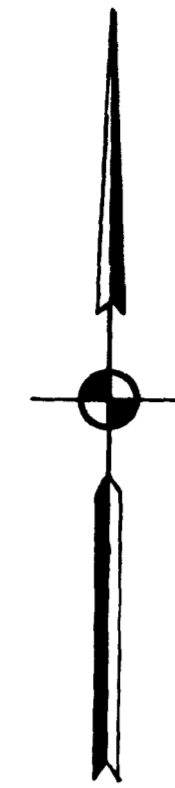


STARKE HEIGHTS - REPLAT

REPLAT OF A SUBDIVISION OF THAT PORTION OF LAND FORMERLY RECORDED IN PLAT BOOK 2, PAGE 33, CURRENT PUBLIC RECORDS OF BRADFORD COUNTY, FLORIDA. AND MORE PARTICULARLY DESCRIBED AS: COMMENCING AT THE NW CORNER OF THE NW 1/4 OF THE SE 1/4 OF SECTION 29, TOWNSHIP 6 SOUTH, RANGE 22 EAST, THENCE N 87° 33' E A DISTANCE OF 321 FEET TO THE POINT OF BEGINNING, THENCE N 87° 33' E A DISTANCE OF 288 FEET, THENCE S 70° 30' E A DISTANCE OF 317.98 FEET, THENCE S 0° 21' E A DISTANCE OF 294 FEET TO THE NORTH RIGHT OF WAY LINE OF STATE ROAD 28, THENCE S 89° 08' W A DISTANCE OF 587 FEET ALONG THE NORTH RIGHT OF WAY LINE OF STATE ROAD 28, THENCE N 0° 21' W A DISTANCE OF 396.65 FEET TO THE POINT OF BEGINNING.

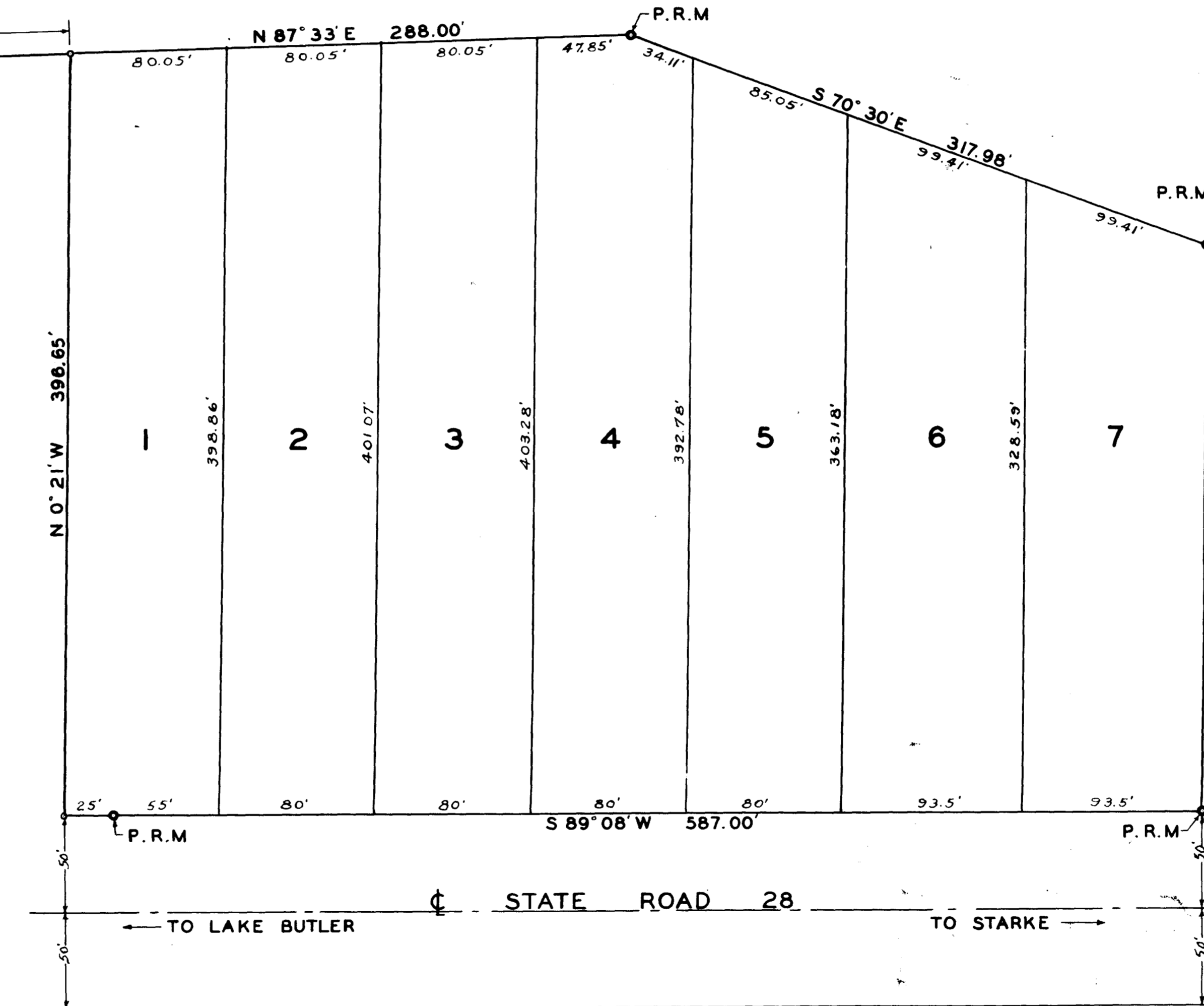
