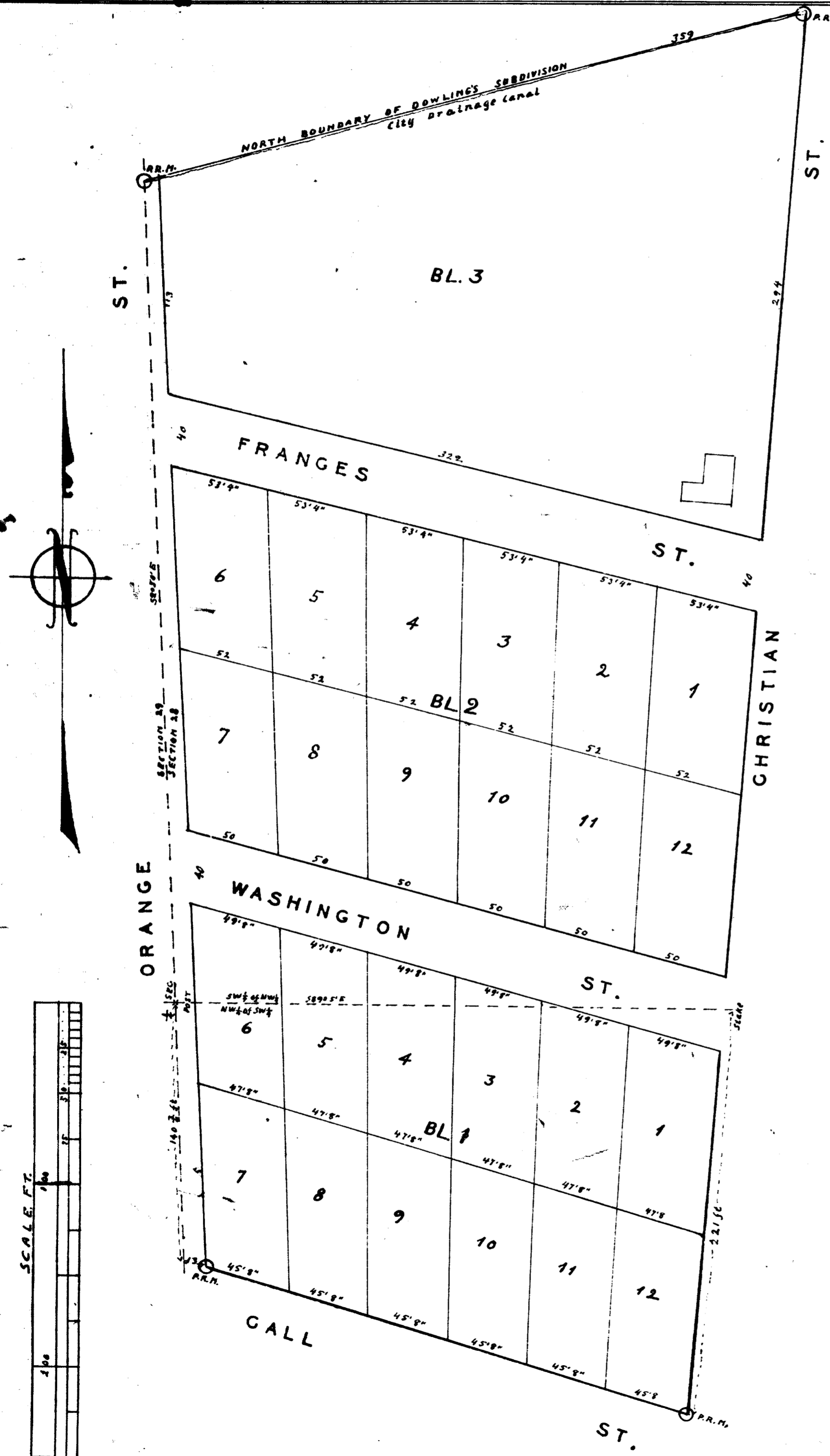


Dowling's Subdivision
