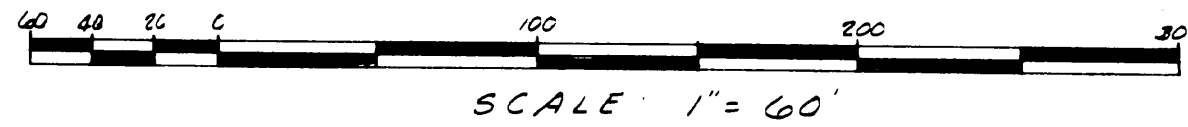


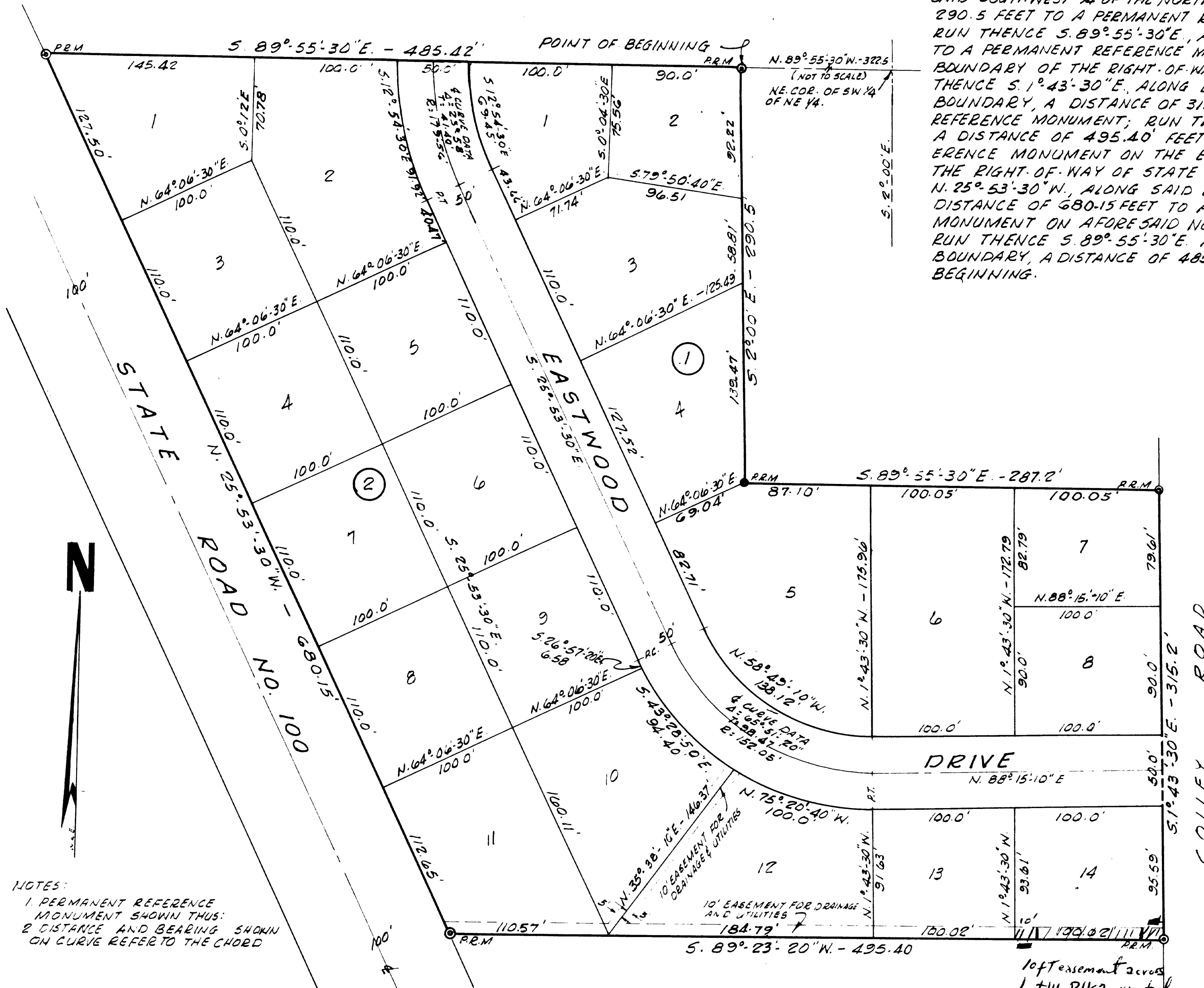
EASTWOOD STARKE, BRADFORD COUNTY, FLORIDA

COMMENCE AT THE NORTHEAST CORNER OF AFORESAID
SOUTHWEST 1/4 OF THE NORTHEAST 1/4 AND RUN THENCE
N. 89° 55' 20" W. ALONG THE NORTHERLY BOUNDARY THEREOF,
A DISTANCE OF 388.5 FEET TO A PERMANENT REFERENCE
MONUMENT FOR POINT OF BEGINNING.
FROM POINT OF BEGINNING THUS DESCRIBED, RUN
S. 2° 00' E. AND PARALLEL TO THE EASTERLY BOUNDARY OF
SAID SOUTHWEST 1/4 OF THE NORTHEAST 1/4, A DISTANCE OF
290.5 FEET TO A PERMANENT REFERENCE MONUMENT;
RUN THENCE S. 89° 55' 30" E., A DISTANCE OF 287.2 FEET
TO A PERMANENT REFERENCE MONUMENT ON THE WESTERLY
BOUNDARY OF THE RIGHT-OF-WAY OF COLLEY ROAD; RUN
THENCE S. 1° 43' 30" E. ALONG LAST AFORESAID WESTERLY
BOUNDARY, A DISTANCE OF 315.2 FEET TO A PERMANENT
REFERENCE MONUMENT; RUN THENCE S. 89° 23' 30" W.
A DISTANCE OF 495.40 FEET TO A PERMANENT REF-
ERENCE MONUMENT ON THE EASTERLY BOUNDARY OF
THE RIGHT-OF-WAY OF STATE ROAD NO. 100; RUN THENCE
N. 25° 53' 30" W. ALONG SAID EASTERLY BOUNDARY, A
DISTANCE OF 680.15 FEET TO A PERMANENT REFERENCE
MONUMENT ON AFORESAID NORTHERLY BOUNDARY,
RUN THENCE S. 89° 55' 30" E. ALONG SAID NORTHERLY
BOUNDARY, A DISTANCE OF 485.42 FEET TO POINT OF
BEGINNING.
