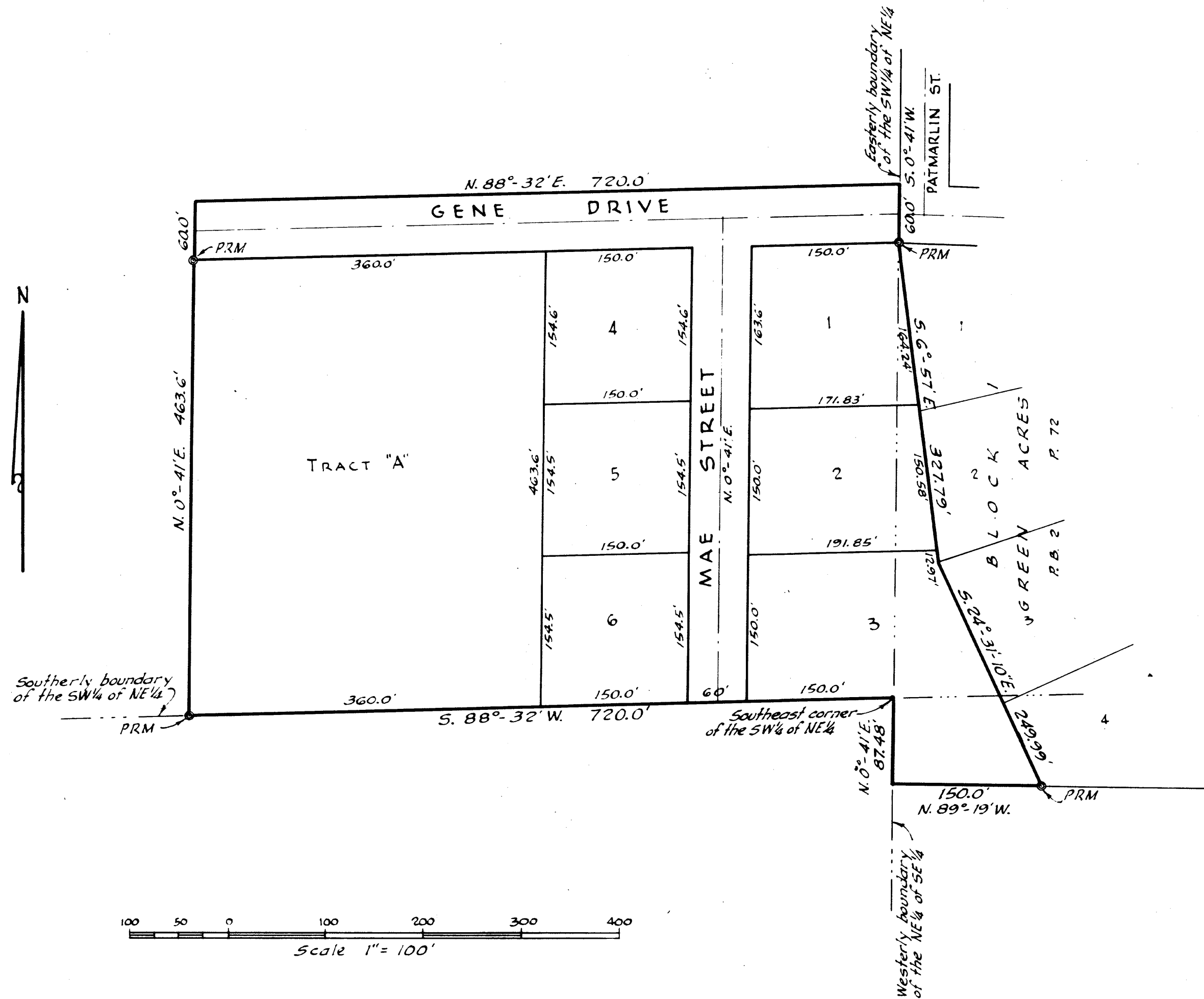


GREEN ACRES ANNEX

BRADFORD COUNTY, FLORIDA

A SUBDIVISION OF A PORTION OF THE SW 1/4 OF THE NE 1/4, A PORTION OF THE SE 1/4 OF THE NE 1/4 AND A PORTION OF THE NE 1/4 OF THE SE 1/4, ALL IN SECTION 20, TOWNSHIP 6 SOUTH, RANGE 22 EAST, THE LANDS HEREBY SUBDIVIDED BEING MORE PARTICULARLY DESCRIBED IN THE CAPTION BELOW



Permanent reference monuments shown thus: PRM

CAPTION

For point of beginning commence at a permanent reference monument located at the northwest corner of Lot 1, Block 1, Green Acres, according to plat recorded in the public records of Bradford County, Florida in Plat Book 2 Page 72, and run South six degrees, fifty-seven minutes East (S. 6° 57' E.) along the westerly boundary of said Block 1, a distance of three hundred twenty-seven and seventy-nine hundredths (327.79) feet to an angle point in said boundary; run thence South twenty-four degrees, thirty-one minutes, ten seconds East (S. 24° 31' 10" E.), continuing along said westerly boundary, a distance of two hundred forty-nine and ninety-nine hundredths (249.99) feet to a permanent reference monument at the south-westerly corner of said Block 1; run thence North eighty-nine degrees, nineteen minutes, West (N. 89° 19' W.) along the westerly prolongation of the southerly boundary of said Block 1, a distance of one hundred fifty (150.0) feet to an iron pipe in the westerly boundary of the NE 1/4 of the SE 1/4 of Section 20 aforementioned; run thence North zero degrees, forty-one minutes East (N. 0° 41' E.) along said westerly boundary of the NE 1/4 of the SE 1/4, a distance of eighty-seven and forty-eight hundredths (87.48) feet to the southeast corner of the SW 1/4 of the NE 1/4 of said Section 20; run thence South eighty-eight degrees, thirty-two minutes West (S. 88° 32' W.) along the said southerly boundary, a distance of seven hundred twenty (720.0) feet to a permanent reference monument; run thence North zero degrees, forty-one minutes East (N. 0° 41' E.) parallel with the easterly boundary of said SW 1/4 of the NE 1/4, a distance of four hundred sixty-three and six tenths (463.6) feet to a permanent reference monument; continue thence North zero degrees, forty-one minutes East (N. 0° 41' E.) a distance of sixty (60.0) feet; run thence North eighty-eight degrees thirty-two minutes East (N. 88° 32' E.) parallel with the southerly boundary of the SW 1/4 of the NE 1/4 aforementioned, a distance of seven hundred twenty (720.0) feet to a point in the easterly boundary said SW 1/4 of the NE 1/4; run thence South zero degrees, forty-one minutes West (S. 0° 41' W.) along said easterly boundary and along the westerly boundary of Green Acres aforementioned, a distance of sixty (60.0) feet to the point of beginning.
